

We, being a trend setter for high quality and productivity believes to set & run parallel high social standards that are well acknowledge by international & national bodies.

Legal Requirements

We believe in complete adherence to the law by all our employees, and, to comply with all the legal standards in the labor code, we respect the legal and moral rights of all our workers.

Forced Labor

By following the labor law, we pay our employees at least the minimum wage required or the prevailing industry wage (Whichever is higher) and provide all legally mandated benefits. We also compensate our employees for overtime hours at the rate established by law (Double their gross wage).

Non-Discrimination

Our factory believes in nondiscrimination and we only look at merit while recruiting and in other matters such as increment etc. There is no difference because of gender, race, religion, age, disability, sexual orientation, nationality or social or ethnic origin on the status /remuneration levels of employees.

Health & Safety

The factory assures a safe and healthy working environment to avoid all types of accidents and injuries. We make a responsible contribution to the health care needs of our employees.

Freedom of Association

Our factory believes in allowing all of its employees to join any organization of their own choice. 
